

ORDINANCE NO. 346

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF BANDERA AMENDING ARTICLE 1.03-CITY COUNCIL, DIVISION 2-MEETINGS, SECTION 1.03.031 PLACE AND TIME; OPEN MEETINGS, OF THE CITY'S CODE OF MUNICIPAL ORDINANCES; REPEALING CONFLICTING PROVISIONS OF THE CITY'S CODE; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE

WHEREAS, the City Council currently meets on the first and third Monday of every month at 7:00 p.m. in the municipal building; and

WHEREAS, the City Council has determined that it would be in their best interest to change the regular meeting days; and

WHEREAS, the proposed change would not likely diminish the ability of the general public to attend the regular meetings of the City Council.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BANDERA, TEXAS, THAT:

SECTION I. ARTICLE 1.03 AMENDED

Article 1.03 of the City of Bandera Code of Ordinances is hereby amended as set forth in the attached **Exhibit A**.

SECTION II. CUMULATIVE CLAUSE

That this Ordinance shall be cumulative of all provisions of the City of Bandera, Texas, except where the provisions of this Ordinance are in direct conflict with the provisions of such ordinances, in which event the more restrictive shall apply.

SECTION III. SEVERABILITY

It is hereby declared to be the intention of the City Council that if any of the sections, paragraphs, sentences, clauses and phrases of this Ordinance shall be declared unconstitutional or otherwise illegal by the valid judgment or decree of any court of competent jurisdiction, such event shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this Ordinance, since the same would have been enacted by the City Council without the incorporation in this Ordinance of any such unconstitutional or illegal phrase, clause, sentence, paragraph or section.

SECTION IV. REPEALER

All portions of the Code of Ordinances or other ordinances that are in conflict with the provisions of this Ordinance be, and the same are hereby repealed and all other portions of the Code of Ordinances or other Ordinances not in conflict with this Ordinance shall remain in full force and effect.

SECTION V. EFFECTIVE DATE

This Ordinance shall take effect immediately from and after its passage and publication as may be required by governing law.

Amend Article 1.03 of the City of Bandera Code of Ordinances as follows (delete strikethrough text and add underlined text):

Sec. 1.03.031 Place and time; open meetings

(a) The city council shall meet regularly on the first (1st) and third (3rd) Thursday ~~Monday~~ of every month at 7:00 pm in the municipal building
